# AGREEMENT OF SCIENTIFIC AND TECHNICAL COOPERATION

# between DONBASS STATE ENGINEERING ACADEMY (Ukraine, Kramatorsk)

# and UNIVERSIDAD DE ANTIOQUIA (Medellin, Colombia)

The Donbass State Engineering Academy (Ukraine) on one part and Universidad de Antioquia (Colombia) on the other part have herein agreed as follows:

#### Clause 1

To exchange the information about their educational establishments, their history, development and plans for the future.

#### Clause 2

To promote the establishment of creative ties between related departments and/or institutes of both institutions primarily aimed at creation, innovation, and investigation.

## Clause 3

To realize scientific and technical cooperation in the following directions:

- Joint fundamental and applied researches;
- Exchange, on equal basis, of scientific publications, rendering assistance with publishing research works of scientists in specialty editions of countries – partners;
- Joint participation in competitions to win international grants;

- Invitation, on equal basis, of representatives of the higher school-partner to take part in the most important scientific and general arrangements (jubilees, conferences, symposia, etc.);
- Exchange of scientists and lecturers to deliver lectures, to organize tutorials, to
  exchange experience in research and teaching methods, to arrange laboratory
  work as well as exchange of students, post-graduate students and persons working
  for Ph. D degree and Dr degree to carry out investigations by special agreements
  on equal basis;
- Invitation of scientists and lecturers of the other party for a probation period at corresponding departments of the higher school-partner.

#### Clause 4

To implement the above-mentioned arrangements and other forms of cooperation by special agreements specifying in them the questions of financing, stimulation, etc.

## Clause 5

The present Agreement is operative as from the day of its signing by both parties and will be valid for 10 years. 6 months before the expiration of this Agreement, the parties sum up the results of their cooperation and make a decision on further operation of this agreement.

#### Clause 6

Each party has the right to terminate this Agreement by notifying in writing. This Agreement is cancelled 3 months from the day stated in the notification.
